Trim Trail - RC met with MR and AM re: funding for trim trail and tennis court for VT. There maybe a solution to the issue of conflict of interests. This will be reviewed with the new VT Chairperson after their AGM.

Pinch points by Old Forge: AMS sent the following response 'I've had a meeting with Andy Kettlewell and discussed this in some detail. Re the 20mph speed limit, pilot schemes are beginning in 10 areas, 8 of which have I believe started and 2 are about to begin, and the report will be prepared after the trials have run for a year so there isn't a prospect of such a limit in the immediate future. Having said that, we feel that North Waltham would be a likely candidate for a 20mph scheme if the evidence from the pilot schemes is positive. Re the pinch points, we are concerned that painting white lines is unlikely to be effective and would also visually clutter what is an unusually unspoilt village centre – and if the 20mph limit happened they might be redundant anyway and white lines are much harder and more expensive to remove than to paint! This is not a no but something to think about first.

Drains - Drains still not been cleaned, AS to call HCC again

Sign by shop - Have applied for a grant from AMS, waiting to hear still

Parking by pond – AS drafted letter that went into school newsletter

Moving speed limit signs - Andy Kettlewell has got back to me again and the situation is: The problem with rural speed limits is first reducing vehicle speed where the speed limit starts and secondly keeping the vehicle speeds down once they are in the speed limit area. I suspect if we extended the 30mph speed limit to the A30 we would see motorists accelerating in the gap before the main village area which would possibly result in higher speeds in the main village area as we wouldn't have the visual impact of the 30mph and village nameplate signs. In addition, vulnerable road users using Popham Lane may have a false sense of security believing they are in a 30mph speed limit but where traffic is actually travelling at higher speeds. With this in mind I would not recommend extending the existing 30mph speed limit. If there are specific concerns along Popham Lane such as an access to a footpath, then we can deal with this using warning signs and carriageway markings.

WWI Commemorations – AS has applied for a grant from AMS for a tree to plant by the pond, still waiting to hear. Coppicing Barley View and Meadow Rise - AS to contact Nicola Clark for an update. She states' I'm so sorry to keep you hanging like this. The storms are keeping us busy and it will be a week or two before we start doing anything else. I'm copying in Paul Johnston so that he is aware of the situation.'

Speakers for APM - Jonathan Moseley Chairman of SOS has agreed in principle to speak SWAG Email Updates - AS confirmed she has registered to receive them however non received so far.
